

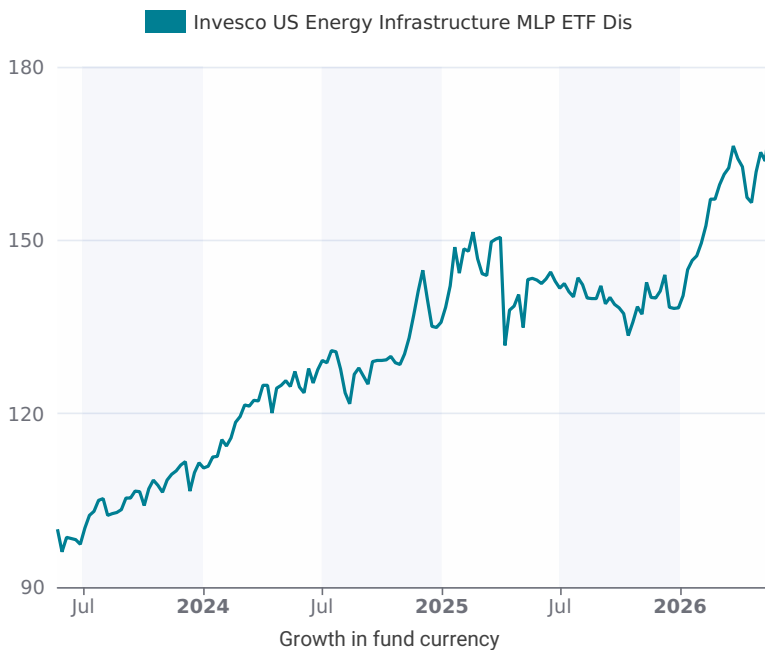

The Index seeks to track U.S. publicly traded energy master limited partnerships (MLPs).

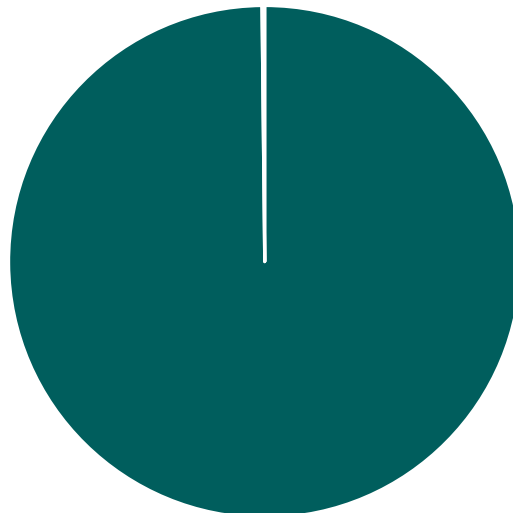
