

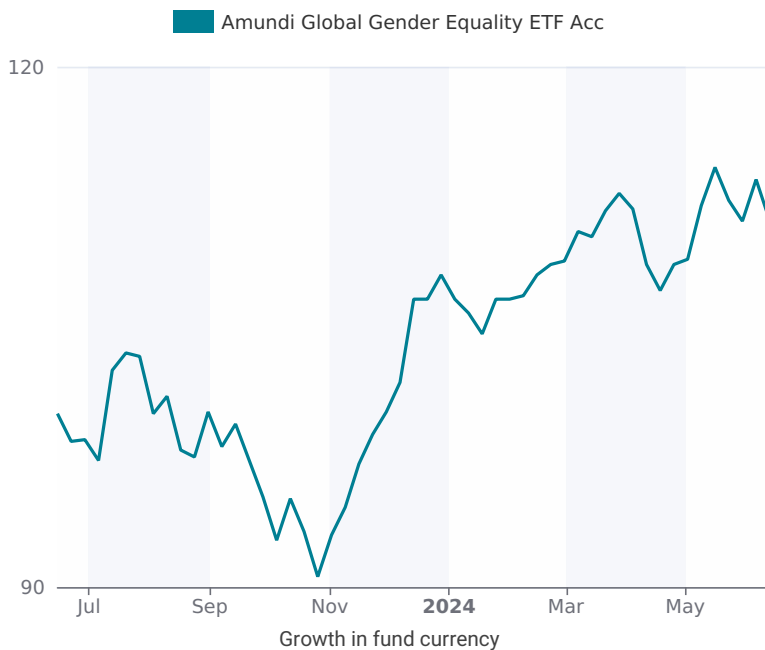

The Benchmark Index aims to offer an exposure to the performance of Global leading companies in the field of gender equality. Companies are selected according to an Environmental, Social and Governance (ESG) screening.

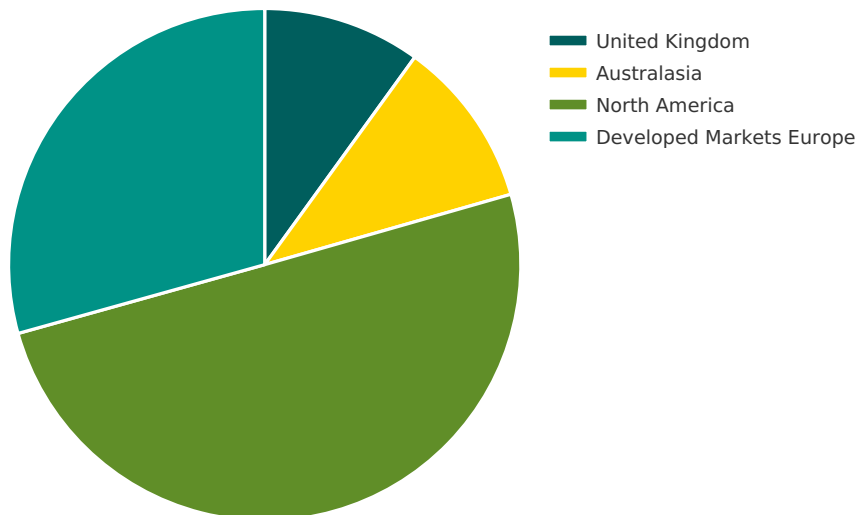
