

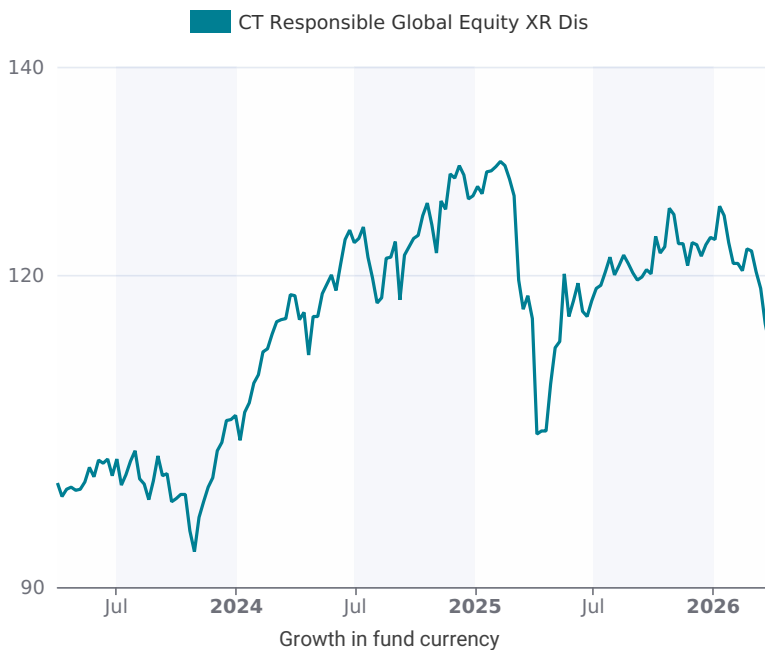

The Portfolio will hold a minimum of 51% in equities that are held on an exchange.

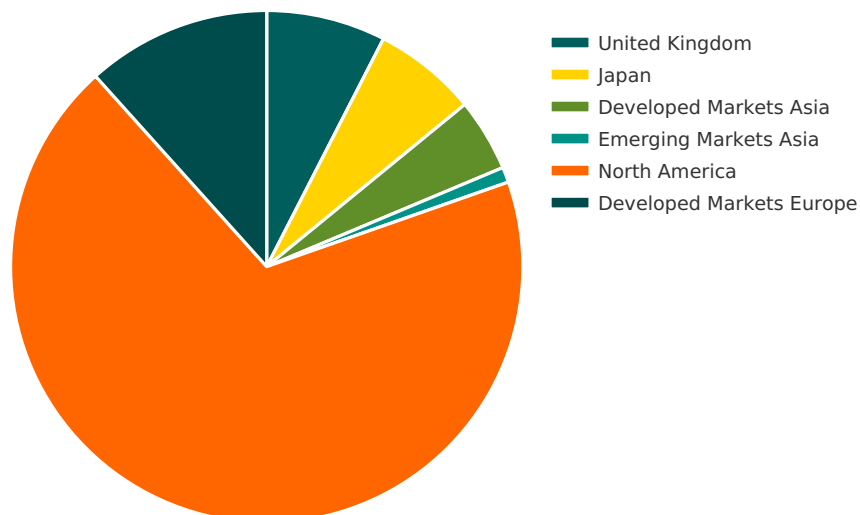
