

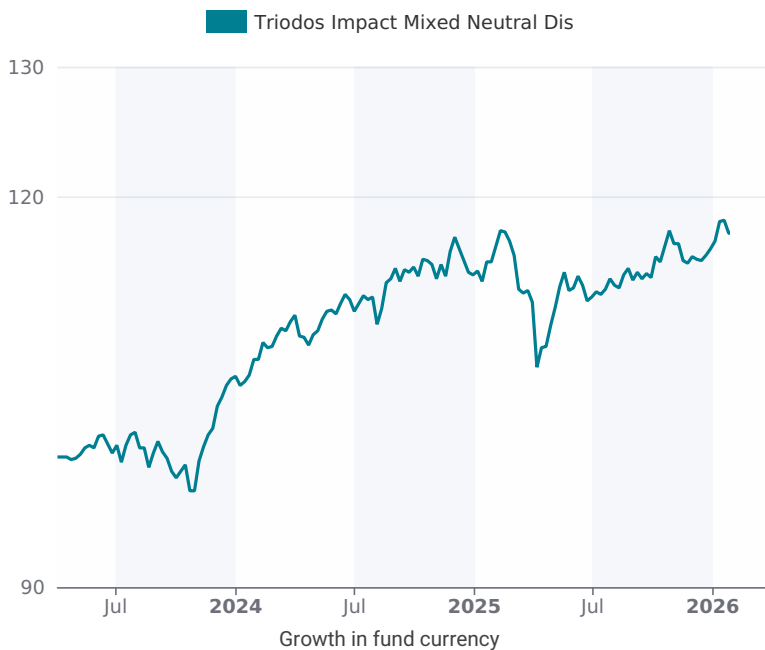

The allocation between shares and bonds is adjusted within the following ranges:
 Shares: minimum 40% - maximum 60%;
 Bonds: minimum 40% - maximum 60%.

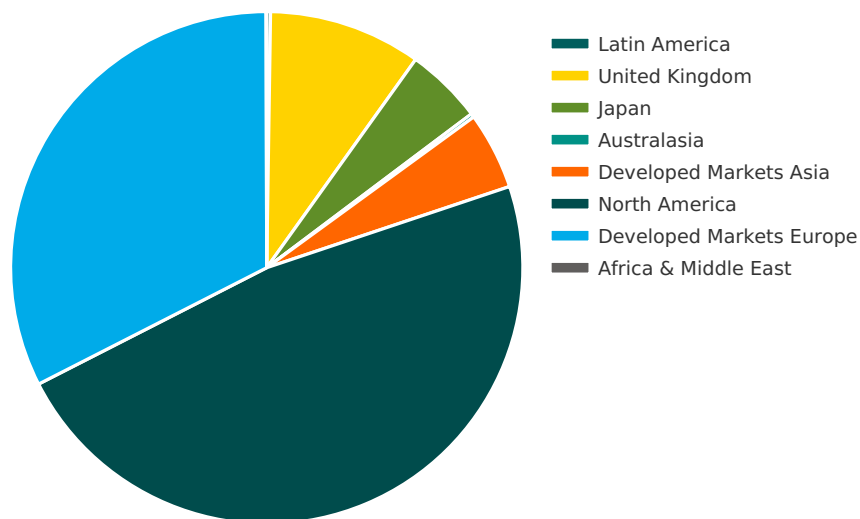
